**Probable Cause Affidavit**

Before me this date personally appeared REYES, RYAN (17938) who being first duly sworn deposes and says that on 13 day of December, (year) 2023 at 3800 NW 39TH ST, LAUDERDALE LAKES, FL 33309 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Detectives began surveillance on the vehicle, approximately 15 minutes later the vehicle became occupied by two individuals (who were later identified as Davontay Mosley / Driver, herein referred to as defendant and Ezekiel Hargrett / rear passenger).

The target vehicle drove north through the parking lot, until reaching NW 41st ST where the target vehicle began driving in an eastbound direction of travel. The target vehicle then turned onto NW 39th AVE and began driving in a south bound direction of travel. The target vehicle then turned onto NW 40th CT and began driving eastbound prior to the road bending to the south. The target vehicle came to a stop in front of 3935 NW 38th Terrace, Lauderdale Lakes, FL at which time Emmanuel Baldwin (herein referred to as the co-defendant) approached the target vehicle. Emmanuel entered the front passenger side door of the vehicle. The target vehicle then continued driving southbound on NW 38th TER, and began approaching NW 39th ST.

While GITF continued surveillance on the vehicle, VIPER began coordinating a take down. VIPER activated their lights and sirens and performed a front and rear block on the target vehicle. The driver side front door opened, and the defendant immediately complied with commands. The defendant was taken into custody without any incident. The co-defendant then also exited from the driver side front door and began fleeing on foot refusing to comply with Law Enforcement commands. Sgt. Romero and Detective Pence gave chase behind of the co-defendant. The co-defendant was taken into custody in the backyard of 3810 NW 39th ST, Lauderdale Lakes, FL. Ezekiel Hargrett also complied with commands and was taken into custody via the rear driver side of the target vehicle. There was a strong odor of fresh cannabis emitting from the defendant. A pat down was conducted on all occupants based on the fact that the vehicle was involved in a

Before me this date personally appeared REYES, RYAN (17938) who being first duly sworn deposes and says that on 13 day of December, (year) 2023 at 3800 NW 39TH ST, LAUDERDALE LAKES, FL 33309 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

shooting. The defendant had a bulge in his sweatpants pocket which was later determined to be a designer type zip lock bag containing Cannabis. Based on my training and experience the designer type zip lock bag is commonly used to package / store cannabis.

I conducted a field test of the Cannabis/THC, using the NIK Cannabis Typification Test and the Cannabis/THC tested positive for 1% or greater of Delta 9 THC concentration. The Cannabis/THC weighed approximately 34 grams.

The cannabis was later packaged and submitted to the BSO drug lab for further testing and court evidence.

FCIC / NCIC revealed that the defendant is currently on probation out of Broward County, for Grand Theft Auto with an end date of 06/16/2025, Case # N41285. It was also discovered that the defendant has never had a Florida Driver License issued to him (CIT # AITRA1E).

The defendant was then transported to BSO main jail via the Broward Sheriff Office Public Safety Building.
