

At approximately 2130 hours, on 12 August 2017, I, Officer Lonnie Brevik, of the Florida Fish and Wildlife Conservation Commission (FWC), was conducting State land patrol, in the area of Hungryland Wildlife Environmental Area (WEA), in Martin County, Florida. Upon driving down Canal Road 4 East, I observed a green Jeep SUV, off the side of the main road, (later identified by valid Florida registration number BIPF64). The vehicle was completely blacked out and in an area that was flooded. I pulled behind the vehicle and activated my marked patrol vehicle's emergency blue lights, to identify myself as a law enforcement officer.

I walked up the vehicle to ensure the occupants were alright, and to see if the vehicle was disabled. I observed one white male, later identified by valid Florida ID card number B361-533-95-146-0, as Logan Mathew Bottorff. I identified the driver, by valid Florida DL number R350-076-91-838-0, as Brittany Renee Reddin. I approached the driver side of the vehicle and asked Reddin to lower the window. As Reddin lowered the window, I immediately detected a strong odor of Cannabis emitting from the vehicle. I asked both occupants if they were alright. She said "we are ok, just talking about relationship stuff". I asked the driver and passenger if they had any illegal substances in the vehicle. Both subjects said that they had smoked a "blunt" on the way out to Hungryland WEA.

I looked in and around the vehicle and observed a pill bottle, with an e-liquid label, outside the passenger side of the vehicle, in the immediate area of Bottorff. The pill bottle contained a green leafy substance that based on my training and experience was Cannabis. I field tested the green leafy substance with my agency issued field test kit, and it tested positive for Cannabis.

I separated both occupants and read them their Miranda warnings, from my agency issued Miranda Warning Card. Both subjects stated that they understood their rights and agreed to speak with me.

I questioned Reddin and she said denied any acknowledgment of the Cannabis.

I questioned Bottorff and he stated that he tossed the pill container of Cannabis out the window prior to me walking up to the window. Bottorff stated that the Cannabis was his. Bottorff stated that the Cannabis was in a pill container with an e-liquid label.

I charged Bottorff with FSS 893.13(6)(b) possession of Cannabis under 20 grams.

I have attached the property receipt, citation, and pictures of the Cannabis/pill container/field test.

Bottorff signed his citation and was released under his own recognizance.

*The Florida Fish and Wildlife Conservation Commission, Division of Law Enforcement hereinafter is referred to as "FWC"*

**UNCLAIMED EVIDENCE:** Pursuant to F.S. 705.105 title to unclaimed evidence or unclaimed tangible personal property lawfully seized pursuant to a lawful investigation in the custody of the court or clerk of the court from a criminal proceeding or seized as evidence by and in the custody of a law enforcement agency shall vest permanently in the law enforcement agency 60 days after the conclusion of the proceeding. If the owner (or their legally appointed agent) does not contact FWC prior to the conclusion of the 60 day period, and there is no request or motion to return property or to appeal, items may be disposed of by FWC.

**LOST / ABANDONED PROPERTY:** Pursuant to F.S. 705.103 property will be held for 90 days from the date of seizure. The rightful owner or a person who initiates a claim for lost/abandoned property must contact FWC and follow the procedure outlined in Florida Statute and the policies of the FWC.
